

**RE: Update on Question #9 of Community Solar Subscriber Organization Registration Form**

Dear Ariane Benrey:

In response to your request for additional information on question #9 of our registration form (list the types of services or products to be offered by the Registrant in New Jersey in connection with community solar), please see below.

SolarStone New Jersey LLC (SolarStone), a community solar developer, will be conducting subscription activities for the sole purpose of subscribing solar energy from facilities we are developing. SolarStone's parent company and its other subsidiaries have collectively subscribed over 40 MWac worth of community solar subscriptions in other markets.

**SOLARSTONE SUBSCRIPTION ACTIVITIES AND OFFERINGS**

Our solar facilities will have a majority (i.e., 51% or more) of LMI subscribers. SolarStone expects to engage some public housing authorities directly, but in general, SolarStone will subscribe general service customers, while our financial partner (and the long-term owner of the projects) will be subscribing residential subscribers.

SolarStone's subscription activities are expected to include:

- **Target Subscriber:** Municipalities, schools, and affordable housing providers.
- **Outreach and Marketing Material:** Given COVID-19, outreach and sales work will be conducted via direct calls and video conferences for the foreseeable future. We focus on leasing land from municipal entities and include them and neighboring municipalities (through referrals) as subscribers. We will execute NDAs with potential subscribers to review their electric data to determine suitable accounts to subscribe, provide BPU's disclosure forms, provide an overview of how community solar works, and then negotiate a subscription agreement.
- **No 3<sup>rd</sup>-Party Contractors:** SolarStone plans to conduct all subscription work activities directly, and not employ a 3<sup>rd</sup>-party contractors as part of our subscription work with non-residential customers.

SolarStone's subscription offering for non-residential subscribers is (as of now) expected to include:

- 20-year subscription agreements with accommodating termination and transfer provisions,
- Guaranteed savings of 20% or more relative to the bill credit value,
