



## **Instructions for Completing the Community Solar Subscriber Organization Registration Form**

The following Registration Form is intended only for community solar subscriber organizations wishing to register with the New Jersey Board of Public Utilities in order to conduct business pertaining to community solar subscriptions in the State of New Jersey, pursuant to N.J.A.C. 14:8-9.10(a).

A "community solar subscriber organization" or "subscriber organization", as defined in N.J.A.C. 14:8-9.2, is an entity, duly registered with the New Jersey Board of Public Utilities, which works to acquire original subscribers for a community solar project and/or acquires replacement subscribers over the lifetime of a community solar project and/or manages subscribers for a community solar project. The community solar subscriber organization may or may not be, in whole, in part, or not at all, organized by the community solar developer, community solar owner, or community solar operator. Furthermore, multiple subscriber organizations may work on one single community solar project; *each* of them must submit a Registration Form. However, each subscriber organization must submit this Registration Form only once, regardless of how many projects said subscriber organization is working on. A new Registration Form must be submitted if there is a material change to the content of the Registration Form.

A subscriber organization wishing to operate in New Jersey is required to complete and submit this form at least 30 days prior to first conducting business operations in New Jersey related to community solar (i.e. prior to acquiring original subscribers for a community solar project and/or acquiring replacement subscribers over the lifetime of a community solar project and/or managing subscribers for a community solar project). Failure to comply may result in a temporary or permanent prohibition from conducting business related to community solar in New Jersey. The Certification under Oath must be notarized.

The Board of Public Utilities will notify subscriber organizations via email of the receipt and administrative completeness of the Registration Form within 30 days of receipt of the Registration Form. If a form is deemed non-administratively complete, a new Registration Form must be submitted.

Additionally, please note that the name and contact information for each registered subscriber organization (questions 1, 2, and 10 in the Registration Form) will be posted on the New Jersey Clean Energy Program website.

**This form is subject to disclosure under the Open Public Records Act, N.J.S.A. 47:1A-1 et seq. If your firm seeks to prevent release of any portion of your submittal, you are required to submit a request for confidential treatment, as set forth in the New Jersey Administrative Code at Title 14, Chapter 1, Subchapter 12. Please note in particular N.J.A.C. 14:1-12.2 and N.J.A.C. 14:1-12.8, which set forth the procedure for requesting confidential treatment, as well as the requirements that entities seeking confidential treatment support their claims with an affidavit, description of the competitive harm the entity would expect to suffer were the information made public, and other related requirements.**


